ANIMAL SHELTER FOUNDED IN 1952, HSSC IS SARASOTA'S OLDEST ANIMAL WELFARE ORGANIZATION. IN 2009, HSSC BECAME A NO-KILL SHELTER. WITH THE COMPLETION OF OUR SHELTER EXPANSION AND RENOVATION PROJECT IN 2021, HSSC IS NOW THE AREA'S PREMIER NO-KILL ORGANIZATION. WE ACHIEVE OUR MISSION BY PROVIDING COMPASSIONATE CARE TO OUR SHELTER PETS, FINDING THEM PERMANENT HOMES, AND PROMOTING RESPONSIBLE PET OWNERSHIP IN OUR COMMUNITY. ON ANY GIVEN DAY, HSSC HAS APPROXIMATELY 200 DOGS AND CATS IN CARE, ADDING UP TO MORE THAN 2,700 LIVES SAVED EACH YEAR. EVERY ANIMAL RECEIVES NUTRITIOUS FOOD, STIMULATING EXERCISE AND ENRICHMENT, AND COMPREHENSIVE MEDICAL CARE AT OUR ONSITE CLINIC.

AS A NON-PROFIT PROVIDER, WE BELIEVE ALL PETS DESERVE ACCESS TO MEDICAL SERVICES TO PREVENT FUTURE HEALTH PROBLEMS. THE ANIMAL CLINIC OFFERS CORE PREVENTATIVE PROGRAMS TO ENSURE PETS REMAIN FREE FROM HARMFUL PARASITES LIKE FLEAS, TICKS, AND HEARTWORMS. WE ALSO OFFER ANNUAL CORE VACCINATIONS TO PREVENT PETS FROM GETTING SICK FROM EXPOSURE TO HARMFUL VIRUSES AND DISEASES.
