ORGANIZATION. IN 2009, HSSC BECAME A NO-KILL SHELTER. WITH THE COMPLETION OF OUR
SHELTER EXPANSION AND RENOVATION PROJECT IN 2021, HSSC IS NOW THE AREA'S PREMIER
NO-KILL ORGANIZATION. WE ACHIEVE OUR MISSION BY PROVIDING COMPASSIONATE CARE TO OUR
SHELTER PETS, FINDING THEM PERMANENT HOMES, AND PROMOTING RESPONSIBLE PET OWNERSHIP
IN OUR COMMUNITY. ON ANY GIVEN DAY, HSSC HAS APPROXIMATELY 200 DOGS AND CATS IN CARE,
ADDING UP TO MORE THAN 2,700 LIVES SAVED EACH YEAR. EVERY ANIMAL RECEIVES NUTRITIOUS
