

HUMANE SOCIETY OF SARASOTA COUNTY 2022 ANNUAL REPORT

2022 was a remarkable year of transformational growth for HSSC. We saved more animals than ever before and increased lifesaving in our community and around our state. Our increased impact directly corresponds to our increased program expenses compared to 2021. Despite rising costs, we were able to maintain an impressive cost ratio and we even reduced non-program spending.

2022 IMPACT NUMBERS

- 2,730 total lives saved
- 98.2% save rate
- **952** dogs and **1,216** cats adopted for a total of **2,168** adoptions
- **343** outdoor cats spay/neutered, vaccinated, and returned
- **1,685** animals pulled from overcrowded shelters in Florida
- **17,770** hours worked by **292** volunteers
- 684 animals fostered
- **60** animals whose lifelong medical needs covered by our TLC fund
- **130** complimentary adoptions to military personnel
- **7,163** pounds of pet food distributed to low-income owners
- **138** K-9 training course graduates
- 62 pet therapy teams
- **153** humane education participants
- **5,403** owned pets treated at the HSSC Animal Clinic
- 9,758 gifts from 4,678 donors

Of our total expenses in 2022, 89% were for programs, 9% for fundraising, and 2% for administration.

As a private nonprofit that does not receive any government funding and is not affiliated with any other humane organization—national or local—HSSC depends on the support of individuals, businesses, and foundations. It is extremely important to us that our supporters know how much we value their investment in our mission and that we demonstrate that we are using their donations wisely. We are committed to fiscal responsibility, transparency, and strong governance. As a result, we have received the coveted 4-Star Rating from Charity Navigator for several consecutive years, as well as the Platinum Seal of Transparency from Candid.

HSSC has a knowledgeable board of directors and a solid investment portfolio. We use generally accepted accounting principles, and we are independently audited. The numbers included in this annual report are from our Audited Financial Statements for the fiscal year ending December 31, 2022.


